# A Year of Change, Innovation, and Pride

Lastly, I want to acknowledge a year of transition. In June 2020, we gave a bittersweet goodbye to my predecessor, Anne Williams-Isom. Anne has settled into her next chapter, now serving as a department chair in the Graduate School of Social Service at Fordham University. Fordham is lucky to have her! Anne, you left big shoes for me to fill—thank you for raising the bar and encouraging me to be better today than I was yesterday.

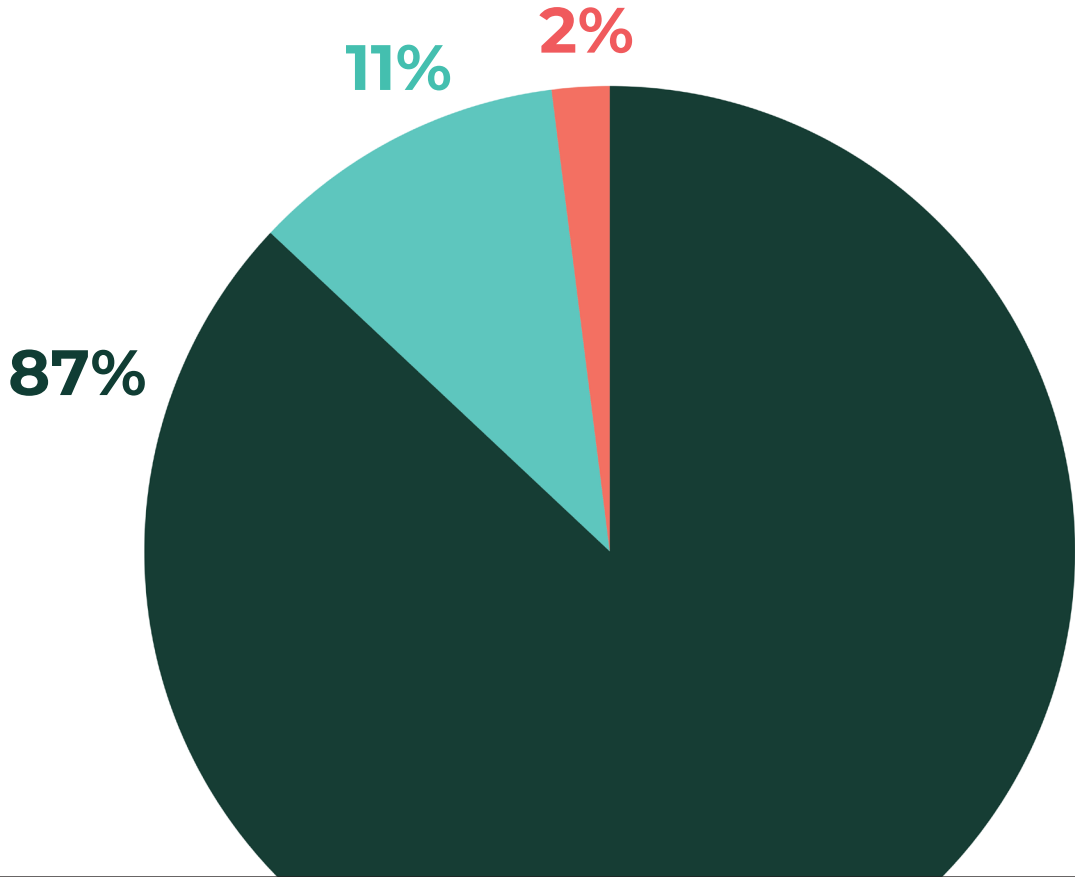
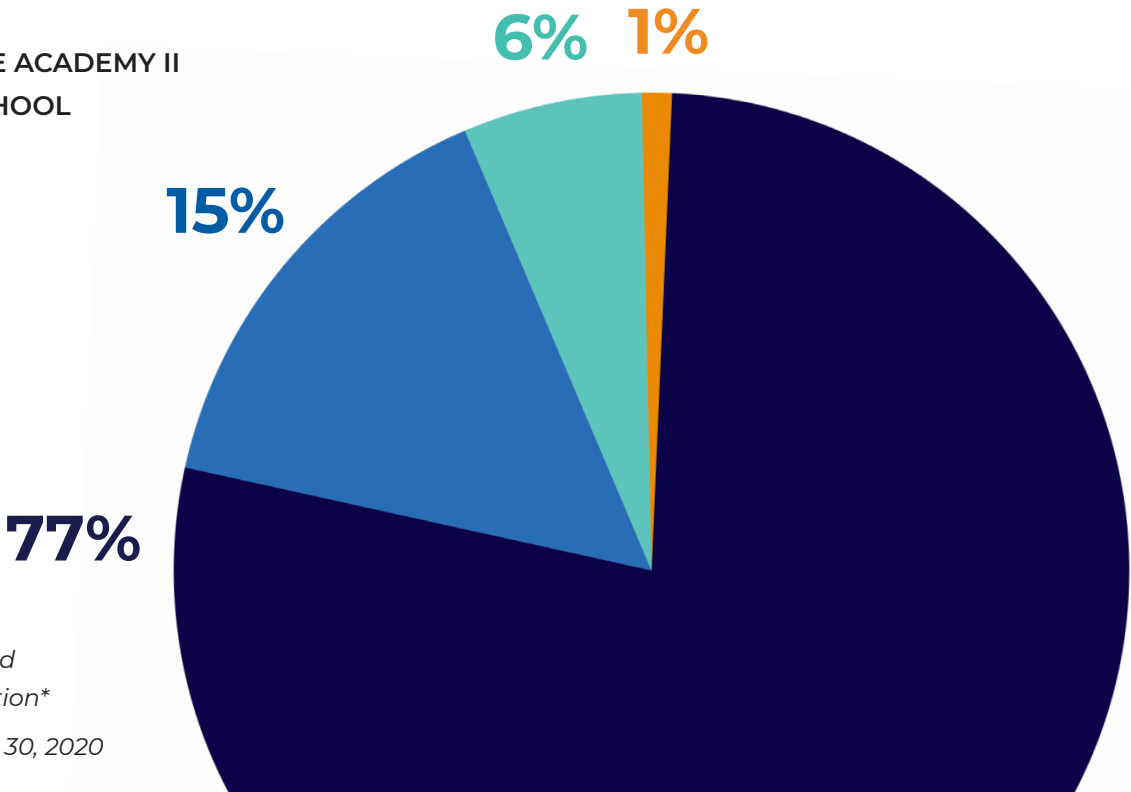

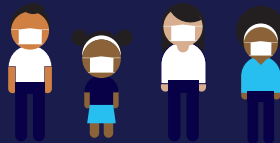
# Twenty years from now...

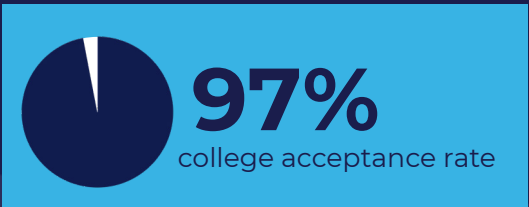

Harlem Gems® PreK opens, and its teachers make sure even Harlem’s littlest children are enthusiastic about working hard to become college graduates and self-sufficient citizens one day.

Promise Academy® II Charter School opens and welcomes many more Harlem scholars into the HCZ family.

HCZ Community Center (now the Geoffrey Canada Community Center) opens its doors as a safe haven for neighbors, families, and friends in Central Harlem.

A second Harlem Gems® location opens. The HCZ education universe grows further.



The Armory—with its sprawling 50,000 square feet—opens to the residents of Central Harlem. The space becomes a hub for sports, fitness, and community events.

The Baby College® extends to include GRADS (Guardians Responding and Developing Strategies) for TBC graduates to deepen knowledge and strengthen parent-child relationships.



Promise Academy's® first high school graduates throw their caps into the air, making HCZ so proud as they prepare to head off to college.

HCZ introduces Healthy Harlem, a program with a mission to help the people of Harlem make better health and nutrition choices in the name of long, vital lives.

Anne Williams-Isom is named CEO. Geoffrey Canada remains President, and the HCZ Community Center on 125th Street is renamed in his honor.

President Barack Obama announces the Promise Zones initiative, inspired by HCZ. Promise Academy® students attend the announcement ceremony at the White House, where Promise freshman Kiara Molina introduces President Obama.



# Promise Academy® Charter Schools

We believe every child has boundless potential. Our job at Promise Academy® is to help scholars identify and unleash their potential—so they will one day graduate from college and progress to successful, fulfilling careers. Along the way, we do whatever it takes to make sure every scholar knows his or her talents and is supported in nurturing them.

Take Mansour—today, he’s a seventh-grade Promise Academy® scholar, years from now he could be a principal clarinetist with one of the world’s great orchestras. In his third-grade orchestra class—which all our scholars take, as we believe a rich education includes the arts—he was asked to play clarinet. His teacher quickly recognized he had a gift. With no prior experience, this young boy was playing with high school-level proficiency.

Determined to do whatever it takes for Mansour to cultivate his natural talent, the Promise Academy® music department customized an accelerated jazz and classical music curriculum for him. They have also facilitated numerous opportunities for him to access enrichment outside of the school, including:

- Support with his successful application to the Manhattan School of Music Summer, for which he received a full scholarship and where he was the youngest student in attendance.
- Coordinating the chance for Mansour to meet and play for Anthony McGill—the esteemed principal clarinetist of the New York Philharmonic.
- Introducing him to invaluable role models, such as accomplished male African American Jazz/Classical musicians.
- The opportunity to perform with older peers within the Promise family in order to see other scholars who look like him excelling in the field of music.
- As a fifth-grader, inviting him to play with the middle school and high school bands.
- Gifting him a new instrument and equipment so that he may compete with the best students in the world. For example, Mansour surpassed level two at his first NYSSMA Solo and Ensemble Festival and received a score of “excellent” on a level three piece as a fifth-grader.

Once in college, Mansour plans to major in engineering and minor in music composition. Like all of our scholars, we cannot wait to see how he continues to grow and achieves great success.

# Healthy Harlem—Harvest Food Distribution



At HCZ, change is a constant. To remain faithful to our mission, we are rigorously culturally responsive—adapting our programs and introducing new ones based on the needs of our community. Healthy Harlem exemplifies this promise.

Healthy Harlem was founded in 2012 to empower HCZ’s children, families, and community residents to develop lifelong healthy habits. The program model focuses on nutrition education, physical activity, and targeted interventions to improve health outcomes. In addition to offering no-cost cooking classes, fitness classes, and wellness workshops, we also have a free food distribution program—and its evolution over the years illustrates our whatever it takes approach to helping everyone in the Zone achieve health and vitality.

In 2013, we expanded upon our existing food distribution activities and established a City Harvest Mobile Market location. Our “Harvests” operate in partnership with City Harvest and local CSAs. For years, Harvests have taken place on the second Saturday of every month in the plaza of the St. Nicholas Housing Development. Participants leave with 15-to-20-pound bags of no-cost fresh fruits and vegetables, as well as recipes inclusive of the ingredients and produce they’ve received.

When the COVID-19 pandemic hit, food insecurity skyrocketed across the entire country. Low-income communities like Harlem, where access to healthy food was already an issue, were hit even harder. Given our unwavering commitment to the health and wellbeing of those in the Zone, we had to intervene—and as quickly and safely as possible. Doing so required that we adapt Harvest and find a way to, yet again, distribute more food to more people.

As of July 2020, we have distributed over 80,000 pounds of produce. While food distribution is now split across multiple sites and the friendly faces of staff and neighbors are safely behind masks, the communal spirit of Harvest remains alive and well. So long as anyone in our community struggles with food insecurity, we will be there to support their health and wellness—the bedrock of living happy, successful, and productive lives.



STUDENT HIGHLIGHT:

# Elijah Dormeus



We can look at Elijah Dormeus’s story in one of two ways. We can see hardship. Or we can see incredible resourcefulness, drive, and hunger for success.

Born in Harlem, Elijah is the fifth oldest of nine children. When he was seven, his Dad passed away, leaving his Mom to raise her family on her own. The family had no choice but to lean on the community and use any resources available to survive.

Despite these struggles, Elijah had a gift for seeing beyond the realities in front of him. Determined to build a resume and go to college, Elijah joined HCZ’s Employment and Technology Center (ETC) when he was a student at Frederick Douglass Academy, a traditional public high school located in Central Harlem. At ETC, Elijah’s dedication earned him the role of Presidential Ambassador, where he liaised between HCZ’s development team and donors. He would later turn this experience into an internship in HCZ’s Development Office. Not only did these opportunities allow him to gain career-

relevant experience, but they also allowed him to network with community and city leaders.

ETC staff were integral to helping Elijah navigate his college applications. With their support, and due to his scholastic achievement and impressive resume, Elijah enrolled in Morehouse College. Throughout his college education, HCZ’s Center for Higher Education and Career Support (CHECS) team stayed with Elijah every step of the way, connecting him with scholarship opportunities, providing guidance to ensure that he remained on track to graduate, and helping him navigate housing challenges. Highlights of Elijah’s college experience were the internship opportunities he found through CHECS. He spent one summer as a Development Officer at Robin Hood, where he analyzed grant requests and Robin Hood’s local partnerships. Elijah was also selected for a competitive, month-long summer internship in Amsterdam, where he worked as a Project Manager at the ReeHorst Hotel.

“At ReeHorst, I was entrusted with the task of producing a book that staff would use to market the hotel to customers,” Elijah said. “In a month’s time, I was learning InDesign, laying out the book, selecting photos, helping translate copy from Dutch to English—and then holding a book that I helped create in my hands. It was intense, fast, fun, and educational—an experience of a lifetime. And I wouldn’t have had it without HCZ.”

Today, Elijah is an AT&T Regional Channel Manager. While he’s worked with AT&T for

less than two years, he’s been promoted twice. After all his resilience and consistent hard work, Elijah is financially independent and thriving.

Elijah—and the five of his siblings who have also participated in HCZ programs—are why we do the work we do. We exist to ensure that every child’s story can turn into one of incredible resourcefulness, drive, and hunger for success, no matter the hardships along the way.



# National Leadership

We're committed to creative partnerships and novel approaches to spreading the HCZ model

Under CEO Kwame Owusu-Kesse's leadership, we are ushering in an era of innovation to broaden the reach of our impact—at home and elsewhere. While we continue to focus our efforts on the people of Central Harlem, we are also committed to sharing our vision with other communities that could benefit from our model. We've gained a lot of wisdom in our twenty years, and our results prove that our approach to fighting intergenerational poverty is working. If we can successfully share our approach with others, we can help them avoid pitfalls, while building higher-impact programs and delivering them faster and more effectively.

## The William Julius Wilson Institute: A Hub for Partners in Place-Based Solutions

With Geoffrey Canada leading the charge, the William Julius Wilson Institute (WJWI)—housed within HCZ—was established. Named in honor of one of our nation's most prolific African American scholars on poverty and inequality, WJWI acts as a hub for place-based partnerships and for backbone organizations to access the supports they need to close opportunity gaps and open pathways to social and economic mobility in neighborhoods across the U.S. We are excited and optimistic about the potential of this promising new Institute.

## The COVID-19 Pandemic: A Case Study in National Leadership

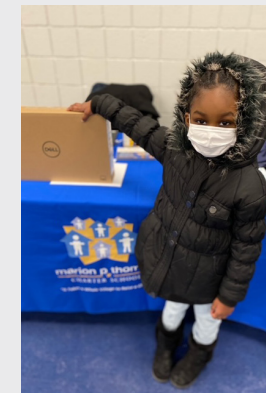
The COVID-19 pandemic hit our community—and Black communities across the United States—with disproportionate ferocity. We had to act, and we had to act fast.

In short order, we conceived a five-pronged emergency response and recovery plan in Harlem to close resource gaps and address vulnerabilities in the fallout of the pandemic:

- Protecting the most vulnerable
- Bridging the digital divide
- Preventing learning loss
- Mitigating the mental health crisis
- Providing economic relief and recovery

HCZ garnered widespread praise for our speed and effectiveness in protecting the people of Harlem. In turn, we partnered with local organizations in six cities (Minneapolis, Oakland, Newark, Detroit, Chicago, and Atlanta) and three national organizations (NAACP, PolicyLink, StriveTogether) to help their leaders replicate our COVID-19 response—and a new model to aid other communities was born. The Audacious Project made a generous \$26 million commitment towards our goal of raising \$50 million to fund ongoing COVID-19 relief and recovery efforts in Harlem and our six partner cities. The newly launched William Julius Wilson Institute at HCZ is serving as the platform for this national effort.

We partnered with local organizations in six cities and three national organizations to help their leaders replicate our COVID-19 response—and a new model to aid other communities was born.
