THE PROMISE ACADEMY SHARES CERTAIN EXPENSES WITH ITS AFFILIATED ORGANIZATIONS, HARLEM CHILDREN'S ZONE ("HCZ") AND THE HARLEM CHILDREN'S ZONE PROMISE ACADEMY II. THESE SHARED EXPENSES INCLUDE PRORATED SALARIES AND OTHER EXPENSES THAT ARE ALLOCATED AMONGST THE ENTITIES. THE NET IMPACT OF THESE SHARED SERVICES IS THAT THE HARLEM CHILDREN'S ZONE PROMISE ACADEMY I RECORDS A DUE FROM RELATED PARTIES TOTALING \$1,678,822 ON ITS BALANCE SHEET.

HCZ ALSO PROVIDES THE CHARTER SCHOOL WITH CERTAIN SERVICES AT NO COST. THESE SERVICES HAVE BEEN VALUED AT \$698,302. IN ADDITION TO CONTRIBUTED SERVICES, THE ACADEMY RECEIVED THE USE OF SPACE AT HARLEM CHILDREN ZONE'S BUILDING LOCATED AT 245 W. 129TH STREET, NEW YORK, NEW YORK. UPON EXECUTION OF THE SUBLEASE AGREEMENT IN FISCAL 2015, THE ACADEMY RECORDED A \$73,279,162 CONTRIBUTION RECEIVABLE, WHICH REPRESENTS THE IMPUTED FAIR VALUE OF THE SPACE UNDER THE LEASE. THE RECEIVABLE IS BEING AMORTIZED TO RENT EXPENSE, AND THE RELATED TEMPORARILY RESTRICTED NET ASSETS ARE RELEASED FROM RESTRICTIONS, OVER THE TERM OF THE LEASE. THE CURRENT CONTRIBUTION RECEIVABLE, AS REPORTED ON THE BALANCE SHEET, IS \$53,127,393.

HCZ MAINTAINS A 457(F) PLAN FOR CERTAIN ELIGIBLE EMPLOYEES OF THE SCHOOL. EMPLOYEES BECOME ELIGIBLE TO PARTICIPATE IN THIS PLAN BASED SOLELY AT THE DISCRETION OF THE SCHOOL'S BOARD OF TRUSTEES. THE AMOUNTS CONTRIBUTED WILL VEST IN EITHER THREE OR FIVE YEARS. HCZ PROVIDES THE SCHOOL WITH AN ANNUAL SUBSIDY TO COVER THIS COST BY CONTRIBUTING TO A HCZ INVESTMENT ACCOUNT. DURING FISCAL 2025, HCZ PROVIDED A SUBSIDY OF \$890,786 FOR THE FISCAL 2025 CONTRIBUTION TO THE 457(F) PLAN. IN
